1. (C) Operations Summary:

a. General: TF 2d Bde, 101st Abn Div continues to conduct offensive operations in support of operation CARAMTAN II to locate and destroy VC/NVA forces, bases, and logistics in the coastal plains area and provide security for Camp EVANS, 12 IANA and WUNDAR Beach. Ememy contact was moderate during the reporting period with a total of four enemy contacts.

Today's statistics: Friendly losses # 3 US KIA, 2 MIA, 2 MIA, 2 WIA (7 medevac). Enemy assessment - 6 NVA: KIA (BC), 1 VC KIA (BC) and 2 AK-47's.
