1. (C) Operations Summary.

a, General: TF 2d Bde, 101st Abn Div continues to conduct offensive operations in support of Operation CARENTAN II to locate and destroy VC/NVA forces, bases, and logistics in the coastal plains area. Contact was light during the reporting period with a total of 6 contacts. Todays statistics: Friendly losses - 6 US WIA (5 medevac). Enemy assessment -5 NVA KIA (BC), 1 AK-47, 1 RPG-2 launcher, 2 B-40 rounds (destroyed), 2 CHICOM grenades (destroyed), 180 rounds SA.
