### 1. (C) Operations Summary:

a. General: TF 2d Bde, 101st Abn Div continued to conduct offensive operations in support of Operation DELAWARE to locate and destroy VC/NVA forces, bases, and logistics in the coastal plains area. Contact was light to include the village complex cordoned by the 2-501 Inf, where sporadic fire was received throughout the night. Today's statistics: Friendly losses - 5 US WIA (5 medevac); Enemy assessment - 32 NVA KIA (BC), 1 NVA POW, 3 AK-47's, 3 SKS, 1 7.62 AK Soviet Assault Rifle, 1 RPG-7 launcher.

(1) Co A. Occupied NDP vic YD695271 with ambushes vic
YD686274 and YD 694274. During the day conducted maintenance 23 2000
and local patrols vic NDP. Established NDP vic YD688268 with Apr 1968

- (1) Throughout the night a cordon was maintained around the village complex along the NW and SE side of stream from vic YD758305 and YD755313. Blocking positions were maintained by Co A, Co C, Co D, 2d plat Co B, 1 RF Co, and 1 ARVN Co. Throughout the reporting period sporadic SA, AW fire and occasional RPG-2 and 82mm rounds were received with negative casualties. Partial sweeps were made of the objective area with the exception of hamlet located vic YD747305. At the close of the reporting period Co's A, D and the RF Co remained in the objective area with a cordon established by ambushes around the hamlet vic YD747305. The ARVN Co was airlifted from the objective area from 1502 hrs to 1604 hrs. At 1611 hrs, the 2d plat of Co B was airlifted to LZ vic YD688318, closed 1620 hrs. During the reporting period there were no friendly casualties in the vic of the cordoned village. Enemy assessment - 32 NVA KIA (BC), 1 NVA POW, 3 AK-47's, 3 SKS, 1 7.62 AK Soviet Assault Rifle, 1 RPG-7 launcher.
- (2) Co B (-). Conducted RIF operation from vic YD685316 to vic YD684306 to vic YD688302. At 1645 hrs vic YD687304 received SA and AW fire from an estimated Co resulting in 2 US WIA (medevac). Arty and an air strike were placed on the enemy positions with negative assessment. Established
