072001H Sep 68 - 082000H Sep 68

1. (C) Operations Summary:

a. General: 2d Bde, 101st Abn Div (Airmobile) continued to conduct offensive operations in support of Operation NEVADA EAGLE to limit and disrupt attempts made by the enemy to extort the VN rice production throughout the coastal plains area and to seek out and destroy enemy forces and installations in the 2d Bde AO. Contact was light with a total of 3 contacts. Today's statistics: 2 US MIA; Enemy assessment.- 4 VC KIA (BC), 15 SKS, 4 AK-47, 2 BAR's, 6 sub-MG's, 2 M1 carbines, 3 M1 rifles, 650 lbs rice, 36 60mm mortar rnds.

At 1450 hrs 1st plat conducted heliborne movement from COL CO Beach to YD888228, closed 1459 hrs. (2) Co B. Occupied night psn vic YD569174 and ambushed vic YD570176, YD577172 and YD582170. Conducted cloverleaf patrolling. At 1917 hrs Co (-) vic YD564175 observed 8 rockets fired from vic YD556215 towards Camp EVANS. Arty and LFT were employed by 1st ACD against the rocket location with Co B assisting in adjustment of counter-rocket fires.
