Commander's Situation Report SUBJECT: 102001H July 68 - 112000H July 68

#### 1. (C) Operations Summary:

a. General: 2d Bde, 101st Abn Div continued to conduct offensive operations in support of Operation NEVADA EAGLE to limit and disrupt attempts made by the enemy to extort the VN rice production throughout the coastal plains area and to seek out and destroy enemy forces and installations in the 2d Bde AO. Contact was light with a total of 8 contacts. Today's statistics: 4 US WHA (4 medevac), 3 VC KIA (BC), '4950 lbs rice.

#### b. 1-501 Inf.

(1) Co A. Occupied night psn vic YD836225 and established 3 local LP's. At 2100 hrs LP vic YD839226 engaged 2 VC with SA, neg enemy assessment. At 2125 hrs LP vic YD839228 adjusted arty on 4 enemy, neg enemy assessment. Conducted RIF 11 2000 opn to vic YD815243, remaining on SE side of river. At 1350 1968 July hrs 6 detainees were evacuated for further classification. At 1935 hrs vic YD806243 received SA fire from 1 enemy, neg cas.
