(C) Operations Summary: 1.

a. General: 2d Bde, 101st Air Cav Div continued to conduct offensive operations in support of Operation NEVADA EAGLE to limit and disrupt attempts made by the enemy to extort the VN rice production throughout the coastal plains area and to seek out and destroy enemy forces and installations in the 2d Bde AO. Contact was light with a total of 6 contacts. Todays statistics: 4 US WHA. Enemy assessment - 4 VC KIA, 1 CHICOM grenade.

(1) Co A. Provided security for COL CO Beach and any bushed vic YD873303.

(3) Co C. Provided security for FSB MONGOOSE and pipeline along highway 551 and POL pumping station vic YD775249.

Did not check the area due to darkness. At 2231 hrs vic YD850226 received SA fire from 2-3 enemy vic YD854228. Arty was employed on the suspected enemy position with unknown results. Conducted RIF operation SE to vic YD856204. Then Co (-) conducted RIF operation to vic YD843206. 1 plat conducted RIF operation S to vic YD853195 then NW to vic YD843204. At 0944 hrs vic YD850203 received sniper fire from vic YD857208. 1 plat maneuvered against the enemy location and searched the area but the enemy had fled. At 1148 hrs vic YD845205 sustained 2 WHA from BBT grenade. Medevac complete 1207 hrs. At 1925 hrs vic YD847203 engaged and killed 1 VC vic YD848203. At 1925 hrs vic YD862212 observed 40-50 males dressed in black. Arty engaged the area causing the personnel to disperse.

against the VC but the VC fled immediately to the southeast. At <u>1735</u> hrs vic YD 600138 engaged 3 enemy vic YD600139 with SA fire. The enemy returned AW fire, resulting in 2 US WHA. 1 squad maneuvered against the enemy supported by arty. The enemy fled immediately to the SE.
