Commander's Situation Report SUBJECT: 052001H Oct 68 - 062000H Oct 68

1. (C) Operations Summary:

a. General: 2d Bde, lOlst Abn Div (Airmobile), continued to conduct offensive operations in support of Operation NEVADA EAGLE to limit and disrupt attempts made by the enemy to extort the VN rice production throughout the coastal plains area and to seek out and destroy enemy forces and installations in the 2d Bde AO. Contact was light during the reporting period. Today's statistics: 3 US WHA (medevac); Enemy assessment - 2 VC KIA (BC), 1 AK-47, 1 K-44.

b. 1-501 Inf. Continued combined US/GVN opn with cordon remaining although some forces occupying blocking psns were exchanged or shifted. The 2-54th ARVN kegt continued to ambush and search within the cordoned area accounting for 5 VC KIA (BC) and 4 IWC.
